<u>September 11, 2023 Minutes approval</u> Motion to approve the minutes as presented was made by Glenda, and seconded by Bert. Motion carried.

- Chris: Maintenance Report 13-14 cats have been fixed so far. Still trying to catch more. The water is off for the year. Handrails are up in the Indoor Arena except for one which is being returned and replaced.
- <u>Jodi</u>: Admin Report –Convention Nov 8-10 in CdA. Hotel reservations and RMAF registrations are all made.
- Paula: Fair Report –Dave motioned that we buy 5 wagons, Glenda seconded the motion. Motion carried. Motion was made by Dave to order crowd control panels at \$85 each x10 panels, and seconded by Glenda. Motion carried. Move the discussion of tabletop displays for fair entries to November's agenda.

Old Business -

- Discuss review of books and accounting procedures Jodi will check with Leonard again for recommendations.
- Dave went to the Eagles meeting and told them that we are concerned that their donation is likely not
 covering the utilities. They will discuss upping the donation they make. He talked to the Shriners about
 moving their booth closer to the Pavilion which will open up the middle of the lawn area so as not to
 block other vendors. The Eagles would be willing to do the beer garden on Saturday night at the fair.

New Business -

- FFA wants to cement the barn and may want our financial help. Ken talked to Gabby. They are considering some ideas but are not ready to move forward right now.
- Dave motioned that we accept Kevin Weber's quote of \$39,700 to finish the wells building. Glenda seconded the motion. Motion carried. Ken will call Larry and release him from the contract. Chris will contact Kevin to get a copy of his insurance.
- Motion to purchase one set of bleachers from ParkWarehouse for \$1,770 and add an additional wheel kit was made by Dave, seconded by Glenda. Motion carried. After we get one in, Chris will look at the quality and perhaps board will want to order another one or two.
- Liz Sat Oct 21 is the FFA auction with dinner at 5:30 and the auction at 6:30. Thur, Oct.26th is the Awards Carnival in Exhibit Hall. 4-H signups are open.
- Parks&Rec discussed adding our PA system wiring to camera wiring when it is installed. They are
 waiting for the bid from EL Internet to put in the conduit. We will send an email to Eric Lederhos as well,
 and CC Rob on the email RMTompkins@icloud.com. P&R applied for water rights to dig a well and we
 would be able to use that to get water to the arena. Looking at putting it by the tennis courts.
- Levi Falck to share ideas for grandstand replacement with community support. (Table for November)
- Tammy Hedrick to discuss a better livestock policy for the fair. (Table for November)
- Oliver Andrews reported on the structural soundness of the old horse barn. Oliver reported that the
 horse barn looks structurally sound. He will present the Board with a plan, and the board will come back
 with anything they want to add including how we want the stalls configured on the inside. He will
 have this to us by the November meeting.
- Legal Notice to be run in Bonners Ferry Herald Fair income and expenses. Glenda approved it to be published in the Herald \$60,321.29.
- Amy Robertson would be willing to help re-write the fair book policy on canned food items.
- Review Fair Office procedures on supply acquisitions and payments. It was decided that the majority of fairgrounds purchases would be done using the County's credit card and/or the existing fairgrounds accounts like those with Quill, and local businesses. The use of personal funds, debit or credit is highly discouraged.
- Debbie Higgins joined the meeting to discuss fair book procedures what is working, changes needed, etc. We would like to get the fair book out earlier in the year at least onto the website by mid-May with the printed version coming out late June. 4-H will order more books this year. Let Debbie know who won the window contest each year. Reimburse 4-H for the free ad from the window contest 2023. Board asked that we discussed the possibility of splitting the fair book between Paula and Jodi if needed add to the November agenda.
- Accessibility to Fort Knox- add to November agenda.
- Dave found a company who can put an ATM on the premises during the fair. We would have to put our cash in it. We would get 3% and the ATM company would get 3%, needs a camera and be hard-wired to the internet. Jodi will check with ICRMP.
- Add meeting time to November's agenda.
