PLEASE READ ALL RULES AND REQUIREMENTS

- 1. Vendor space is NOT reserved until the application, payment, proof of insurance (if applicable) and tax forms are received in the Fair Office. Returning Vendors will be given the opportunity to reserve their same space from the previous year. **Pre-Booking reservations** can be made by submitting the Pre-Booking Application, and the \$25 Rental Security Deposit as soon as the previous year's fair is over. An email with the updated pricing will be sent in mid-February, at which point, as long as the full booth fee and required paperwork are received in the Fair Office on or before **MARCH 15**, the returning vendors previous years space will be reserved. After that date, booth selections will open up to anyone, and will be assigned on a first come-first served basis.**
- 2. Please provide a full menu with prices. Each menu will be reviewed to avoid duplication of food items.** Please check with Panhandle Health for food handling requirements. Failure to comply or cancellation after July 23 will result in forfeiture of payment and vendor space. Food vendors must guarantee and provide a \$1,000,000 Certificate of Insurance wherein Boundary County Fair Board and its agents are additional named insured on a broad form comprehensive general liability endorsement or commercial general liability.
- 3. Set-up time is Sunday, AUG 6th from 8 AM-8 PM, and Monday, AUG 7th, 7 AM-9 PM.** Cargo trailers will be permitted on grounds during set-up but must be removed to designated parking area on the west side of the fairgrounds (near the mill) during the fair. Fair closes at 9 PM daily. **Take-down is Saturday, August 12th after 8:00 PM and Sunday, August 13th until 12:00 PM. NO EARLY TAKE-DOWN as this will result in forfeiture of the \$25 deposit and not invited back the following year.**
- 4. Meal Tickets MUST be turned in by Sunday, August 13th at 12:00 PM or vendor will not be reimbursed.** Reimbursement checks will be issued with the deposit refund and mailed after they are signed at the September board meeting.
- 5. After-hours security watchmen are provided; however, each vendor is responsible for securing their vendor space by removing valuables at night. The Boundary County Fair Board is not responsible for loss or damage of vendor items.**
- 6. All fair rules and regulations must be followed. Selling of products, raffle tickets, drawings, distribution of any materials, etc., is permitted **only** within your vendor space. The Boundary County Fair Board has the right to: reject any product, item or material to be sold or given away if deemed detrimental to the fair and inspect premises at any time to ensure proper food handling practices. Failure to comply can result in being asked to vacate and forfeiture of fees. **Panhandle Health may inspect vendor areas on any given day during the fair.****
- 7. Some internet will be available in limited areas for a fee.**

NO DOGS ALLOWED ANYTIME ON THE FAIRGROUNDS OR BUILDINGS DURING THE FAIR, AUGUST 6th – 13th. YOU WILL BE ASKED TO REMOVE THEM.
