# Call to Order of the Monthly Board Meeting— at 5:31 pm.

# Jaycee: Fair Report -

- Wyatt Bucking Bulls were here to discuss the possibility of squeezing in a rodeo during the fair. Details will need to be worked out, but it might work.
- Donna Griffin, with SPOT Bus, discussed how a route might be beneficial during fair to ferry people from other parking lots to the fairgrounds to remedy the shortage of parking. She and Jaycee will make a plan.
- Jaycee reported that she is getting responses by local bands who are interested in performing at the Summer Concert series. She shared a contract that she had put together, and will run it past the county attorney.
- She shared several entertainment companies we could hire for fair.
- We received a verbal barn sponsorship from Houck Farms for the FFA barn of \$2,500/year for five years. FFA Alumni may also be interested in sponsoring, and raised the question if two entities could sponsor one barn.
- The Beer & Wine license is finally moving forward.
- After using the colored entry tags we have in stock, we will switch to using all white entry tags for fair.
- There is old sound equipment that has not been used for years and is obsolete. This will be surplused, removed from our inventory records, and turned over to Squire for auction.
- It was decided to increase the donation given to Search & Rescue for their security services during the fair. Glenda made the motion to increase this from \$500 to \$750. Bert seconded the motion. Motion carried.
- Kootenai County is sponsoring a fair board conference. Our board is invited to attend on Saturday March 1 from 10:00-2:00. Ken and Jaycee plan to attend.

<u>Facilities, Expense & Payroll Financial report</u> – Glenda made a motion to pay the bills of \$4,065.61, payroll of \$4,483.28, and an additional check of \$3,500 for fair ribbons for a total of \$12,048.89. Bert seconded the motion. Motion carried.

- Stacey has been developing an Outdoor Arena Condition Policy which describes how it needs to be after events. (move to March)
- Dave has been researching companies and the cost of getting better soil and having it cleaned/sifted in the Outdoor Arena (move to March)

#### New Business -

- Bert made a motion that the current CD's be rolled-over by March 4, with the \$60,000 CD at 6 months at 3.38% and the \$30,000 CD for 3 months at 3.44%. Glenda seconded the motion. Motion carried.
- Glenda motioned that we hire a summer intern to work with Jaycee, and that they be at least 19 years of age so they can help with the beer and wine sales. Bert seconded the motion. Motion carried.
- Overnight parking/camping. The Commissioners passed an ordinance that a maximum of 48 hours will be allowed for parking on county property, unless otherwise posted.
- For the 2025 fair, Glenda made a motion that we rent a mechanical bull, and look at purchasing one in a future year. Bert seconded the motion. Motion carried.
- Mark Carpenter will be added to the March agenda to do a sound system presentation for the fair.
